## Soviet and Nazi Defectors

Analyzes nine wartime and postwar defections, highlighting motivations, risks, and counter-intelligence significance. A well-informed defector is the most dangerous counter-intelligence commodity because it takes a spy to catch a spy. Very occasionally, an agent, especially a mole or an intelligence professional, will make a mistake and incriminate themselves, but usually it is a denunciation, a tip, or a vague clue from a defector that will provide the vital information required to expose the source of a leak. Relying on recently-declassified intelligence files and interviews with defectors, their handlers, their families, and their victims, Nigel West has analyzed nine examples of wartime and postwar defections to shed new light on the phenomenon. Defectors are notoriously difficult to handle, and resettle, because of the range of genuine or invented motives that led them to take such drastic action. Some will provide a noble political motive, seeking to impress their host, while others may be driven by less worthy compulsions – perhaps greed, revenge, career disappointment, envy, anger, or nothing more complicated than a desire to start a life afresh with a different partner. Defectors are the stock-in-trade for all counter-intelligence specialists who seek the background and context of corridor gossip and water-cooler chat cannot be substituted by any amount of technical surveillance, overhead reconnaissance or hard to-interpret intercepted communications. This is the essence of Human Intelligence, and goes to the heart of loyalty, trust, betrayal and deception – the very DNA of espionage. These nine examples of switching sides all involve intelligence professionals who followed the example of Erich Vermehren. Because of his religious convictions, Vermehren felt compelled to desert the Abwehr in January 1944, even though this meant the arrest of his parents and siblings who were consigned to Sachsenhausen concentration camp. West traced Vermehren, then living under an alias in Switzerland, to hear his story first-hand. He then interviewed the British MI6 officer who had engineered the covert exfiltration from Istanbul of both the German and his wife. Sometimes a defection may be the result of a period of cultivation, as happened with Vladimir Petrov, who was gently persuaded over many months by his Polish dentist to abandon his clandestine role as resident in Canberra for a chicken farm. The intermediary, Dr Michael Bialoguski, admitted to the author that right up to the moment of his defection, he and his Australian Security Intelligence organization colleagues were not entirely sure of Petrov's true status. Once resettled, a defector's life has daily challenges, as was explained by Yuri Rastvorov's widow, herself a CIA counter-intelligence officer, who recalled the day she had to tell their two daughters that their father was not a Czech tennis coach, but an NKVD defector who had been based in Tokyo.

## Defectors and the Liberal Party 1910–2010

This book is the first analysis of political defections over a long time span. It investigates all the Liberal/Liberal Democrat MPs and former MPs who defected from the party between the elections of December 1910 and May 2010 - around one sixth of all those elected - as well as the smaller number of inward defectors. Each of the 122 defections was an expert judgment on the state of the party at a specific date. The research investigates the timing and reasons for all the defections and reveals long-term trends and underlying causes and apportions responsibility between leaders for them. The author finds some significant differences which distinguished defectors from loyalists and draws wider conclusions about the underlying factors which lead MPs to defect. This book will be of interest to students and lecturers of British politics and anyone interested in the relationship between British political parties in the last century.

## North Korean Defectors in a New and Competitive Society

Ongoing ideological or political conflicts in the modern world have led to appalling human rights violations

against North Korean defectors who attempt to escape from their repressive country and seek freedom. ## **Interviews with North Korean Defectors**

The 33 interviews herein are listed chronologically according to the interviewees' date of arrival to South Korea and span almost 70 years. The book also includes six special columns addressing key issues pertaining to North Korean defectors and their lives in South Korea, such as the relationship between North Korean defectors and their South Korean counterparts (South Korean defectors to North Korea; nomenclature (how North Korean defectors have been referred to in South Korean society over time); arrival and settlement provisions from the South Korean government; the nuanced difference between defectors, defector-residents, and the displaced; North Korean defector-residents and their position in South Korean politics; and a short biography of five notable North Korean defector-residents who were not interviewed. The English translation also contains an exclusive 34th interview with Lim Il, the source text author which was carried out towards the end of the project in October 2020. The book is a valuable testament to North Korean defector-residents and unique in that it provides a candid account of each individual's experience. It will prove to be especially useful to students and scholars seeking to understand the complex dynamics of North Korean society and the status of exiles in South Korea, and a vital resource for students of Korean Studies.

The mathematics and statistics used by researchers are generally avoided. Both theory and evidence are presented, but the focus is on the ideas that provide a coherent conceptual framework that grounds a deeper exploration of the theoretical and empirical research in the economics of religion.

His book makes a clear and compelling case for understanding every living system—and everything that arises as a consequence of living systems—in terms of evolutionary dynamics.

The future of oncology seems to lie in Molecular Medicine (MM). MM is a new science based on three

pillars. Two of them are evident in its very name and are well known: medical science and molecular biology. However, there is a general unawareness that MM is firmly based on a third, and equally important, pillar: Systems Biomedicine. Currently, this term denotes multilevel, hierarchical models integrating key factors at the molecular, cellular, tissue, through phenotype levels, analyzed to reveal the global behavior of the biological process under consideration. It becomes increasingly evident that the tools to construct such complex models include, not only bioinformatics and modern applied statistics, as is unanimously agreed, but also other interdisciplinary fields of science, notably, Mathematical Oncology, Systems Biology and Theoretical Biophysics.

## **Disability, Media, and Representations**

North Korea's human rights violations are unparalleled in the contemporary world. ## **From Juche to Jesus**

In this book, a social dilemma with partner selection is introduced and studied with the methods of formal game theory, experimental economics and computer simulations. They suggest ways to model within one individual the separate motivations of public spirit and self-interest, investigate public spirit and self-interest, investigate public spirit in citizen and legislative behavior, and demonstrate that the view of democracy in existing Constitutional interpretations is not based on self-interest. They advance both human evil and mothering as alternatives to self-interest, this last in a penetrating feminist critique of the "contract" model of human interaction.

## **New Challenges for Cancer Systems Biomedicine**

Weighing the very limited individual rights allowed, the authors illustrate how the political class system and the legal system serve solely as tools of the regime. The key to understanding how the North Korean people live, the authors argue, is to realize that their only allowed role is to support Kim Jong-un, whose grandfather founded the country in the late 1940s. Still a cypher, Kim Jong-un, as did his father before him, controls his people by keeping them isolated and banning most foreigners. North Koreans remain hungry and oppressed, yet the outside world is slowly filtering in, and the book concludes by urging the United States to flood North Korea with information so that its people can make decisions based on truth rather than their dictator's ubiquitous propaganda.

## **The Korean War and Postmemory Generation**

Brian Skyrms, author of the successful *Evolution of the Social Contract* (which won the prestigious Lakatos Award) has written a sequel. The book is a study of ideas of cooperation and collective action. The point of departure is a prototypical story found in Rousseau's *A Discourse on Inequality*. Rousseau contrasts the pay-off of hunting hare where the risk of non-cooperation is small but the reward is equally small, against the pay-off of hunting the stag where maximum cooperation is required but where the reward is so much greater. Thus, rational agents are pulled in one direction by considerations of risk and in another by considerations of mutual benefit. Written with Skyrms's characteristic clarity and verve, this intriguing book will be eagerly sought out by students and professionals in philosophy, political science, economics, sociology and evolutionary biology.

## **Modeling Complex Systems**

This book shows that evolutionary game theory can unravel how mutual cooperation, trust, and credit in a group emerge in organizations and institutions. Some organizations and institutions, such as insurance unions, credit unions, and banks, originated from very simple mutual-aid groups. Members in these early-stage mutual-aid groups help each other, making rules to promote cooperation, and suppressing free riders. Then, they come to “trust” not only each other but also the group they belong to, itself. The division of labor occurs when the society comes to have diversity and complexity in a larger group, and the division of labor also requires mutual cooperation and trust among different social roles. In a larger group, people cannot directly interact with each other, and the reputation of unknown people helps other decide who is a trustworthy person. However, if gossip spreads untruths about a reputation, trust and cooperation are destroyed. Therefore, how to suppress untrue gossip is also important for trust and cooperation in a larger group. If trustworthiness and credibility can be established, these groups are successfully sustainable. Some develop and evolve and then mature into larger organizations and institutions. Finally, these organizations and institutions become what they are now. Therefore, not only cooperation but also trust and credit are keys to understanding these organizations and institutions. The evolution of cooperation, a topic of research in evolutionary ecology and evolutionary game theory, can be applied to understanding how to make institutions and organizations sustainable, trustworthy, and credible. It provides us with the idea that evolutionary game theory is a good mathematical tool to analyze trust and credit. This kind of research can be applied to current hot topics such as microfinance and the sustainable use of ecosystems.
