Critical race theory (CRT) is a conceptual framework developed to understand the relationships between social conceptions of race and ethnicity, social - Critical race theory (CRT) is a conceptual framework developed to understand the relationships between social conceptions of race and ethnicity, social and political laws, and mass media. CRT also considers racism to be systemic in various laws and rules, not based only on individuals' prejudices. The word critical in the name is an academic reference to critical theory, not criticizing or blaming individuals.

CRT is also used in sociology to explain social, political, and legal structures and power distribution as through a "lens" focusing on the concept of race, and experiences of racism. For example, the CRT framework examines racial bias in laws and legal institutions, such as highly disparate rates of incarceration among racial groups in the United States. A key CRT concept is intersectionality—the way in which different forms of inequality and identity are affected by interconnections among race, class, gender, and disability. Scholars of CRT view race as a social construct with no biological basis. One tenet of CRT is that disparate racial outcomes are the result of complex, changing, and often subtle social and institutional dynamics, rather than explicit and intentional prejudices of individuals. CRT scholars argue that the social and legal construction of race advances the interests of white people at the expense of people of color, and that the liberal notion of U.S. law as "neutral" plays a significant role in maintaining a racially unjust social order, where formally color-blind laws continue to have racially discriminatory outcomes.

CRT began in the United States in the post-civil rights era, as 1960s landmark civil rights laws were being eroded and schools were being re-segregated. With racial inequalities persisting even after civil rights legislation and color-blind laws were enacted, CRT scholars in the 1970s and 1980s began reworking and expanding critical legal studies (CLS) theories on class, economic structure, and the law to examine the role of US law in perpetuating racism. CRT, a framework of analysis grounded in critical theory, originated in the mid-1970s in the writings of several American legal scholars, including Derrick Bell, Alan Freeman, Kimberlé Crenshaw, Richard Delgado, Cheryl Harris, Charles R. Lawrence III, Mari Matsuda, and Patricia J. Williams. CRT draws on the work of thinkers such as Antonio Gramsci, Sojourner Truth, Frederick Douglass, and W. E. B. Du Bois, as well as the Black Power, Chicano, and radical feminist movements from the 1960s and 1970s.

Academic critics of CRT argue it is based on storytelling instead of evidence and reason, rejects truth and merit, and undervalues liberalism. Since 2020, conservative US lawmakers have sought to ban or restrict the teaching of CRT in primary and secondary schools, as well as relevant training inside federal agencies. Advocates of such bans argue that CRT is false, anti-American, villainizes white people, promotes radical leftism, and indoctrinates children. Advocates of bans on CRT have been accused of misrepresenting its tenets and of having the goal to broadly censor discussions of racism, equality, social justice, and the history of race.

Caucasian race

The Caucasian race was historically regarded as a biological taxon which, depending on which of the historical race classifications was being used, usually included ancient and modern populations from all or parts of Europe, Western Asia, Central Asia, South Asia, North Africa, and the Horn of Africa.

Introduced in the 1780s by members of the Göttingen school of history, the term denoted one of three purported major races of humankind (those three being Caucasoid, Mongoloid, and Negroid). In biological anthropology, Caucasoid has been used as an umbrella term for phenotypically similar groups from these different regions, with a focus on skeletal anatomy, and especially cranial morphology, without regard to skin tone. Ancient and modern "Caucasoid" populations were thus not exclusively "white", but ranged in complexion from white-skinned to dark brown.

Since the second half of the 20th century, physical anthropologists have switched from a typological understanding of human biological diversity towards a genomic and population-based perspective, and have tended to understand race as a social classification of humans based on phenotype and ancestry as well as cultural factors, as the concept is also understood in the social sciences.

In the United States, the root term Caucasian is still in use as a synonym for people considered "white" or of European, Middle Eastern, or North African ancestry as defined by the United States census. Currently, its continued usage as a racial descriptor has been criticized. The term also sees usage in other English-speaking countries like Australia.

RuPaul's Drag Race

The show documents RuPaul in the search for "America's next drag superstar". RuPaul plays the role of host, mentor, and head judge for this series, as contestants are given different challenges each week. Contestants are judged by a panel that includes RuPaul, Michelle Visage, one of four rotating judges (Carson Kressley, Ross Mathews, Ts Madison, or Law Roach), as well as one or more guest judges, who critique their progress throughout the competition. The title of the show is a play on drag queen and drag racing, and the title sequence and song "Drag Race" both have a drag-racing theme.

RuPaul's Drag Race has aired for seventeen seasons and inspired the spin-off shows RuPaul's Drag U, RuPaul's Drag Race All Stars, RuPaul's Secret Celebrity Drag Race, and RuPaul's Drag Race Global All Stars; the companion series RuPaul's Drag Race: Untucked; and numerous international franchises.

The show became the highest-rated television program on Logo TV, and airs internationally, including in the United Kingdom, Australia, Canada, the Netherlands and Israel. The show earned RuPaul eight consecutive Emmy Awards (2016 to 2023) for Outstanding Host for a Reality or Competition Program. The show has been awarded the Primetime Emmy Award for Outstanding Reality-Competition Program four consecutive times (2018 to 2021), and the Outstanding Reality Program Award at the GLAAD Media Awards. It has been nominated for five Critics' Choice Television Awards including Best Reality Series – Competition and Best Reality Show Host for RuPaul and numerous Creative Arts Emmy Awards.

Race (human categorization)

Race is a categorization of humans based on shared physical or social qualities into groups generally viewed as distinct within a given society. The term came into common usage during the 16th century, when it was used to refer to groups of various kinds, including those characterized by close kinship relations. By the 17th century, the term began to refer to physical (phenotypical) traits, and then later to national affiliations. Modern science regards race as a social construct, an identity which is assigned based on rules made by society. While partly based on physical similarities within groups, race does not have an inherent physical or biological meaning. The concept of race is foundational to racism, the belief that humans can be divided based on the superiority of one race over another.

Social conceptions and groupings of races have varied over time, often involving folk taxonomies that define essential types of individuals based on perceived traits. Modern scientists consider such biological essentialism obsolete, and generally discourage racial explanations for collective differentiation in both physical and behavioral traits.

Even though there is a broad scientific agreement that essentialist and typological conceptions of race are untenable, scientists around the world continue to conceptualize race in widely differing ways. While some researchers continue to use the concept of race to make distinctions among fuzzy sets of traits or observable differences in behavior, others in the scientific community suggest that the idea of race is inherently naive or simplistic. Still others argue that, among humans, race has no taxonomic significance because all living humans belong to the same subspecies, *Homo sapiens sapiens*.

Since the second half of the 20th century, race has been associated with discredited theories of scientific racism and has become increasingly seen as an essentially pseudoscientific system of classification. Although still used in general contexts, race has often been replaced by less ambiguous and/or loaded terms: populations, people(s), ethnic groups, or communities, depending on context. Its use in genetics was formally renounced by the U.S. National Academies of Sciences, Engineering, and Medicine in 2023.

Race suicide

Race suicide was an alarmist eugenicist theory, coined by American sociologist Edward A. Ross around 1900 and promoted by, among others, Harry J. According to the American Eugenics Archive, "race suicide" conceptualizes a hypothetical situation in which the death rate of a particular "race" supersedes its birth rate.

As a propagandistic theory akin to white genocide, race suicide was mechanized to induce fear in dominant and/or majority "races" (i.e. the "white race") that their community was dying off and being replaced by more fertile immigrant "races". This term was likewise deployed to proliferate the ideology of eugenics among the international public throughout the 20th century. Moreover, the concept of "race suicide" predominantly placed blame on women, as supposed agents of reproduction. With its roots in Nordicism, the application of this alarmist theory varied based on the targeted community and/or country.

Daniel L. Haynes

Americans, Haynes thought highly of the film. He is quoted as having said: "I cannot say what our race owes King Vidor and Metro-Goldwyn-Mayer—there are - Daniel L. Haynes (June 6, 1889 – July 28, 1954) was an American stage and film actor and clergyman. He is best known for starring as Zeke in King Vidor's early talking film *Hallelujah*, the first film ever to feature an all-Black cast. On November 28, 1910, he married Rosa Belle Sims in Chicago. In his last years, he left show business and became a full-time Baptist minister.

Despite *Hallelujah*'s controversial depiction of Black Americans, Haynes thought highly of the film. He is quoted as having said: "I cannot say what our race owes King Vidor and Metro-Goldwyn-Mayer—there are not words forceful enough for that. *Hallelujah* will, as Moses led his people from the wilderness, lead ours from the wilderness of misunderstanding and apathy."

Various theories about the race of Jesus have been proposed and debated. By the Middle Ages, a number of documents, generally of unknown or questionable origin, had been composed and were circulating with details of the appearance of Jesus. These documents are now mostly considered forgeries.

A wide range of depictions have appeared over the two millennia since Jesus's death, often influenced by cultural settings, political circumstances and theological contexts. Many depictions are interpretations of spurious sources, and are generally historically inaccurate.

By the 19th century, theories that Jesus was non-Semitic were being developed, with writers suggesting he was variously white, black, or some other race other than those known to have been native to the Levant. However, as in other cases of the assignment of race to biblical individuals, these claims have been mostly based on cultural stereotypes, ethnocentrism, and societal trends rather than on scientific analysis or historical method.

What Is a Nation?

"What Is a Nation?" (French: *Qu'est-ce qu'une nation ?*) is an 1882 lecture by French historian Ernest Renan (1823–1892) at the Sorbonne, known for the statements that a nation is "a daily plebiscite", and that nations are based as much on what people jointly forget as on what they remember. It is frequently quoted or anthologized in works of history or political science pertaining to nationalism and national identity. It exemplifies a contractualist understanding of the nation.

Race and ethnicity in the United States census

The Census - In the United States census, the U.S. Census Bureau and the Office of Management and Budget (OMB) define a set of self-identified categories of race and ethnicity chosen by residents, with which they most closely identify. Residents can indicate their origins alongside their race, and are asked specifically whether they are of Hispanic or Latino origin in a separate question.

Race and ethnicity are considered separate and distinct identities, with a person's origins considered in the census. Racial categories in the United States represent a social-political construct for the race or races that respondents consider themselves to be and, "generally reflect a social definition of race recognized in this country". The OMB defines the concept of race as outlined for the census to be not "scientific or anthropological", and takes into account "social and cultural characteristics as well as ancestry", using "appropriate scientific methodologies" that are not "primarily biological or genetic in reference." The race categories include both racial and national-origin groups.

From the first United States Census in 1790 to the 1960 Census, the government's census enumerators chose a person's race. Racial categories changed over time, with different groups being added and removed with each census. Since the 1970 Census, Americans provide their own racial self-identification. This change was due to the reforms brought about by the Civil Rights Act of 1964 and the Voting Rights Act of 1965, which required more accurate census data. Since the 1980 Census, in addition to their race or races, all respondents are categorized by membership in one of two ethnic categories, which are "Hispanic or Latino" and "Not Hispanic or Latino." This practice of separating "race" and "ethnicity" as different categories has been criticized both by the American Anthropological Association and members of US Commission on Civil Rights.

Since the 2000 Census, Americans have been able to identify as more than one race. In 1997, the OMB issued a Federal Register notice regarding revisions to the standards for the classification of federal data on race and ethnicity. The OMB developed race and ethnic standards in order to provide "consistent data on race and ethnicity throughout the federal government". The development of the data standards stem in large measure from new responsibilities to enforce civil rights laws. Among the changes, The OMB issued the instruction to "mark one or more races" after noting evidence of increasing numbers of mixed-race children and wanting to record diversity in a measurable way after having received requests by people who wanted to be able to acknowledge theirs and their children's full ancestry, rather than identifying with only one group. Prior to this decision, the census and other government data collections asked people to report singular races.

As of 2023, the OMB built on the 1997 guidelines and suggested the addition of a Middle Eastern or North African (MENA) racial category and considered combining racial and ethnic categories into one question. In March 2024, the Office of Management and Budget published revisions to Statistical Policy Directive No. 15: Standards for Maintaining, Collecting, and Presenting Federal Data on Race and Ethnicity that included a combined question and a MENA category, while also collecting additional detail to enable data disaggregation.
