Suez Canal

The Suez Canal (/?su?.?z/; Arabic: ???? ??????, Qan?t as-Suwais) is an artificial sea-level waterway in Egypt, connecting the Mediterranean Sea to the - The Suez Canal (; Arabic: ???? ??????, Qan?t as-Suwais) is an artificial sea-level waterway in Egypt, connecting the Mediterranean Sea to the Red Sea through the Isthmus of Suez and dividing Africa and Asia (and by extension, the Sinai Peninsula from the rest of Egypt). It is the border between Africa and Asia. The 193.30-kilometre-long (120.11 mi) canal is a key trade route between Europe and Asia.

In 1858, French diplomat Ferdinand de Lesseps formed the Compagnie de Suez for the express purpose of building the canal. Construction of the canal lasted from 1859 to 1869. The canal officially opened on 17 November 1869. It offers vessels a direct route between the North Atlantic and northern Indian oceans via the Mediterranean Sea and the Red Sea, avoiding the South Atlantic and southern Indian oceans and reducing the journey distance from the Arabian Sea to London by approximately 8,900 kilometres (5,500 mi), to 10 days at 20 knots (37 km/h; 23 mph) or 8 days at 24 knots (44 km/h; 28 mph). The canal extends from the northern terminus of Port Said to the southern terminus of Port Tewfik at the city of Suez. In 2021, more than 20,600 vessels traversed the canal (an average of 56 per day).

The original canal featured a single-lane waterway with passing locations in the Ballah Bypass and the Great Bitter Lake. It contained, according to Alois Negrelli's plans, no locks, with seawater flowing freely through it. In general, the water in the canal north of the Bitter Lakes flows north in winter and south in summer. South of the lakes, the current changes with the tide at Suez.

The canal was the property of the Egyptian government, but European shareholders, mostly British and French, owned the concessionary company which operated it until July 1956, when President Gamal Abdel Nasser nationalised it—an event which led to the Suez Crisis of October–November 1956. The canal is operated and maintained by the state-owned Suez Canal Authority (SCA) of Egypt. Under the Convention of Constantinople, it may be used "in time of war as in time of peace, by every vessel of commerce or of war, without distinction of flag." Nevertheless, the canal has played an important military strategic role as a naval short-cut and choke point. Navies with coastlines and bases on both the Mediterranean Sea and the Red Sea (Egypt and Israel) have a particular interest in the Suez Canal. After Egypt closed the Suez Canal at the beginning of the Six-Day War on 5 June 1967, the canal remained closed for eight years, reopening on 5 June 1975.

The Egyptian government launched construction in 2014 to expand and widen the Ballah Bypass for 35 km (22 mi) to speed up the canal's transit time. The expansion intended to nearly double the capacity of the Suez Canal, from 49 to 97 ships per day. At a cost of LE 59.4 billion (US\$9 billion), this project was funded with interest-bearing investment certificates issued exclusively to Egyptian entities and individuals.

The Suez Canal Authority officially opened the new side channel in 2016. This side channel, at the northern side of the east extension of the Suez Canal, serves the East Terminal for berthing and unberthing vessels from the terminal. As the East Container Terminal is located on the Canal itself, before the construction of the new side channel it was not possible to berth or unberth vessels at the terminal while a convoy was running.

Suez

It is the capital and largest city of the Suez Governorate. It has three ports: the Suez Port (Port Tewfik), al-Adabiya, and al-Zaytiya, and extensive port facilities. Together, the three cities form the Suez metropolitan area, located mostly in Africa with a small portion in Asia.

Railway lines and highways connect the city with Cairo, Port Said, and Ismailia. Suez has a petrochemical plant, and its oil refineries have pipelines carrying the finished product to Cairo. These are represented in the flag of the governorate: the blue background refers to the sea, the gear refers to Suez's status as an industrial governorate, and the flame refers to the petroleum firms of Suez.

The modern city of Suez is a successor of the ancient city of Clysma, a major Red Sea port and a center of monasticism.

Suez Crisis

The Suez Crisis, also known as the second Arab–Israeli war, the Tripartite Aggression in the Arab world and the Sinai War in Israel, was a British-French-Israeli - The Suez Crisis, also known as the second Arab-Israeli war, the Tripartite Aggression in the Arab world and the Sinai War in Israel, was a British-French-Israeli invasion of Egypt in 1956. Israel invaded on 29 October, having done so with the primary objective of re-opening the Straits of Tiran and the Gulf of Aqaba as the recent tightening of the eight-year-long Egyptian blockade further prevented Israeli passage. After issuing a joint ultimatum for a ceasefire, the United Kingdom and France joined the Israelis on 5 November, seeking to depose Egyptian president Gamal Abdel Nasser and regain control of the Suez Canal, which Nasser had earlier nationalised by transferring administrative control from the foreign-owned Suez Canal Company to Egypt's new government-owned Suez Canal Authority. Shortly after the invasion began, the three countries came under heavy political pressure from both the United States and the Soviet Union, as well as from the United Nations, eventually prompting their withdrawal from Egypt. The Crisis demonstrated that the United Kingdom and France could no longer pursue their independent foreign policy without consent from the United States. Israel's four-month-long occupation of the Egyptian-occupied Gaza Strip and Egypt's Sinai Peninsula enabled it to attain freedom of navigation through the Straits of Tiran, but the Suez Canal was closed from October 1956 to March 1957.

U.S. president Dwight D. Eisenhower had issued a strong warning to the British if they were to invade Egypt; he threatened serious damage to the British financial system by selling the American government's bonds of pound sterling. Before their defeat, Egyptian troops blocked all ship traffic by sinking 40 ships in the canal. It later became clear that Israel, the UK, and France had conspired to invade Egypt. These three achieved a number of their military objectives, although the canal was useless.

The crisis strengthened Nasser's standing and led to international humiliation for the British—with historians arguing that it signified the end of its role as a world superpower—as well as the French amid the Cold War (which established the U.S. and the USSR as the world's superpowers). As a result of the conflict, the UN established an emergency force to police and patrol the Egypt–Israel border, while British prime minister Anthony Eden resigned from his position. For his diplomatic efforts in resolving the conflict through UN initiatives, Canadian external affairs minister Lester B. Pearson received a Nobel Peace Prize. Analysts have argued that the crisis may have emboldened the USSR, prompting the Soviet invasion of Hungary.

2021 Suez Canal obstruction

The Suez Canal was blocked for six days from 23 to 29 March 2021 by the Ever Given, a container ship that had run aground in the canal. The 400-metre-long - The Suez Canal was blocked for six days from 23 to 29 March 2021 by the Ever Given, a container ship that had run aground in the canal.

The 400-metre-long (1,300 ft), 224,000-ton, 20,000 TEU vessel was buffeted by strong winds on the morning of 23 March, and ended up wedged across the waterway with its bow and stern stuck on opposite canal banks, blocking all traffic until it could be freed. Egyptian authorities said that "technical or human errors" may have also been involved. The obstruction occurred south of the two-channel section of the canal, so other ships could not pass. The Suez Canal Authority (SCA) hired Boskalis through its subsidiary Smit International to manage marine salvage operations. The blockage of one of the world's busiest trade routes slowed trade between Europe, Asia, and the Middle East, tying up goods worth an estimated US\$9.6 billion per day. By 28 March, at least 369 ships were queuing to pass through the canal.

On 29 March, Ever Given was partially re-floated and moved by about 80 percent in the correct direction, although the bow remained stuck until the ship was finally freed by fourteen Egyptian, Dutch, and Italian tugs at 15:05 EGY (13:05 UTC). As the ship was towed towards the Great Bitter Lake for technical inspection, the canal was checked for damage and found to be sound. The SCA allowed shipping to resume at 19:00 EGY (17:00 UTC). No injuries were reported during the incident.

The vessel was impounded by the Egyptian government on 13 April when its owner and insurers refused to pay the demanded billion-dollar compensation. In July, a formal settlement for an undisclosed sum was reached between the ship owner, the insurers, and the Canal Authority. The ship set sail again on 7 July 2021, stopping for inspections at Port Said before continuing to its original destination, port of Rotterdam. After the incident, the Egyptian government announced that they will widen the narrower parts of the canal.

Isthmus of Suez

As of 2022, Engie employed 96,454 people worldwide with revenues of €93.86 billion.

Engie is listed on the Euronext exchanges in Paris and Brussels and is a constituent of the CAC 40 index. The company was headed from 2016 to 2020 by Isabelle Kocher, who significantly transformed it, notably by deciding to exit coal activities and by investing in renewable energy and energy transition services. Despite the company's commitment to diversification, the majority of its primary activities still revolve around fossil fuels.

Suez Company (1858–1997)

The Suez Company or Suez Canal Company, full initial name Compagnie universelle du canal maritime de Suez (Universal Company of the Maritime Canal of - The Suez Company or Suez Canal Company, full initial name Compagnie universelle du canal maritime de Suez (Universal Company of the Maritime Canal of Suez), sometimes colloquially referred to in French as Le Suez ("The Suez"), was a company formed by Ferdinand de Lesseps in 1858 to operate the Egyptian granted concession of the Suez Canal, which the company built between 1859 and 1869. Initially, French investors held half of the Company's stock, with Egypt's ruler Sa'id Pasha holding most of the balance. In 1875, financial distress forced Sa'id's successor Isma'il Pasha to sell the country's shares to the government of the United Kingdom. The Suez Company operated the canal until Egypt's new president Gamal Abdel Nasser revoked its concession in 1956 and transferred canal operation to the state-owned Suez Canal Authority, precipitating the Suez Crisis.

Following the loss of the canal concession, the Suez Company received financial compensation from the Egyptian government, the final payment of which was made in 1962, and used this resource to reinvent itself as a major investment and holding company in France. In 1958 it renamed itself the Compagnie financière de Suez ("Suez Financial Company"), and in 1967 changed its name again to Compagnie financière de Suez et de l'Union parisienne, a change that was reversed in 1972. It was nationalized in 1982, then privatized in 1987. It acquired control of the Société Générale de Belgique in 1988, and changed name again to Compagnie de Suez in 1990. In 1997, it merged with water utility and construction conglomerate Lyonnaise des eaux to form Suez-Lyonnaise des eaux. The merged entity renamed itself as Suez in 2001 and underwent several subsequent mergers, spin-offs, and restructurings that led to the creation of the energy company Engie and the water and waste-management utility also named Suez.

Ever Given is registered in Panama and her technical management is the responsibility of the German ship management company Bernhard Schulte Shipmanagement.

On 23 March 2021, while traveling from Tanjung Pelepas in Malaysia to Rotterdam in the Netherlands, the ship ran aground in the Suez Canal, blocking the channel. She remained in place for six days before salvage crews freed her on 29 March 2021. The vessel was impounded by the Egyptian government on 13 April 2021 for refusing to pay a reported \$916 million in fees demanded by the government, including \$300 million in "loss of reputation". The compensation claim was later cut down to \$600 million. In early July 2021, the ship was released by the Egyptian authorities following an agreement on compensation.
